Vehicles will bring wood waste onto the site in HGV vehicles. These will be weighed on a weighbridge when coming onto the site before travelling to the waste reception area. The wood waste will be tipped onto the concrete floor and then shredded in a slow speed shredder, in order to reduce the void in the material. It will then be transferred to the storage bays using a loading shovel. The fuel material will be stored in these bays for approximately 10 weeks. During this time the material will be turned/mixed and monitored with temperature probes. The bays will be situated 20m/6m apart to meet the requirements of the Environmental Agency's Fire Prevention Guidance. Prior to being fed into the REGF biomass facility, the wood waste material will be transferred from the wood storage yard to the existing wood yard using a loading shovel. It will then be shredded to a finer consistency and transferred into the REGF biomass facility using a loading shovel. Two lagoons will be in place which will take the surface water drainage. This is capable of accommodating fire water run-off and has a valve which can be closed to prevent fire water flowing into the Welland River.
