Removal of the 'sensitive receptor' on the Grand Union Canal to the South of the proposed Dodmoor Bridge between the existing A5 and West Coast Mainline (Receptor 13).

The receptor was identified in the Environmental Statement and acoustic fencing proposed from the proposed roundabout on the A5, west to the new roundabout on the A45. However, constructing the fence requires widening the embankment, extending safety barrier and impractical extension over the bridge itself and is considered a disproportional cost compared to the benefits to the Grand Union Canal, which will continue to experience noise from the nearby A5 and West Coast Mainline. In addition, there would be a whole life cost to local authority to maintain the acoustic fence and extended safety barrier.

The landscape chapter of the Environmental Statement has also been reviewed and confirms that the fence is not required to provide any landscape mitigation. Landscape mitigation in this area is provided by the planting scheme.
