Proposal to build a Plastic Recycling/Recovery Facility involving the conversion of waste plastic by pyrolysis into diesel, petrol and liquid petroleum gas. Waste plastics will pre-treated off-site and arrive as cleaned segregated feedstock. The feedstock will be processed back into a 'crude' state before being refined into various specification of high-quality liquids for road-fuel use. In practice these liquids will be blended elsewhere into standard road fuel and be finally sold through traditional road fuel outlets. An amount of Liquid Petroleum Gas (LPG) will also be created and used on-site in standard gas boilers in order to provide renewable energy for the plant.
